CLUB-BOAT HIRE AGREEMENT DAY HIRE FORM, 2016

This Agreement sets out the conditions under which a club-owned dinghy is hired out on a daily basis.

This form must be filled in at the start of the Sailing Season in order to hire a boat on a daily basis

1. Club-boat hire is only available to a fully paid up Senior / Family / Junior member
2. The hirer will have responsibility on the day of hire for all aspects of looking after the boat, ensuring it is used safely and properly, returned to the dinghy park at the end of the day in a clean and tidy condition, properly secured and any damage reported.
3. In the event of persistent misuse or any occasion of gross misuse of boat, the Club may terminate this hire agreement at any time without any refund of monies paid.
4. The boat is only available for use on the water when a club safety boat is already on the water. Under no circumstances can a club boat be launched at any other time.
5. The Club retains the right to use the boat for any training-course being run. All effort will be made to ensure this does not interfere with club-racing.

6. The hirer is responsible for any loss or damage caused during the hire period to the dinghy or other persons/property and will either

- Pay the full amount for replacement parts/repair costs

or

- In the event of an insurance claim, pay the amount of the excess applicable

whichever is less

7. The hirer has read and agrees to abide by the Club Sailing Instructions, in particular to all aspects in relation to safety.

8. It remains the responsibility of the hirer to decide whether to sail, to satisfy themselves that the boat is seaworthy, and that they and their crew are sufficiently competent to cope with the prevailing conditions. NYC can accept no responsibility for the conduct and safety of the boat and crew during the hire period.

9. Where conditions are considered marginal or unsuitable for junior or inexperienced sailors, the Race Officer, a safety boat helm or a Flag Officer may refuse permission to the hirer to launch the club boat, or if already afloat that they return to shore.

10. All hire fees and/or costs will be settled at the end of each Series Hire Period
